<b>Analysis of artifacts:</b> 1). Student Outcome: <b>PERFORMANCE CRITERIA</b> * - <i>How was data analyzed? (attach rubrics/scoring tools if used).</i> The students in the traditional format, as well as in the dual credit classrooms, were given an identical test, centered upon the use of the past subjunctive. The assessment was scored on the basis of grammatical accuracy of the necessary verb forms. For each question, the students were asked to provide the appropriate form of the verb, based on context. 2). <b>COMPARABILITY</b> – <i>How did you determine if the outcomes of the traditional and alternative delivery modes were comparable?</i> (note “na” if delivery modes were not compared). I compared the mean scores of the dual credit classes with the mean score earned by my students in the traditional format.	
<b>Summary of RESULTS*:</b> 1). <i>Restate the assessment question(s) (from the Assessment plan):</i> Can students effectively use past-tense subjunctive verbs to communicate about a variety of topics? 2). <i>Summarize the assessment results. A narrative summary is required. Charts, tables or graphs are encouraged but optional.</i> The mean score for CUNE students was 29 out of a possible 40 points. The mean scores of the submitted dual credit schools were: 38, 36, 40, 22, and 37. 3). <b>INTERPRETATION</b> * - <i>Discuss how the results answer the assessment question(s).</i> The assessment results demonstrate that students were able to accurately utilize the past subjunctive, based on the context clues provided in the sentences. The assessment also reflected their ability to distinguish between the two moods in Spanish (the indicative and the subjunctive). 4). <i>Observations made that were not directly related to the question(s).</i> (i.e. interrater reliability of the scoring tool was low) 5). <b>How did the outcomes of the traditional and alternative format analysis compare?</b> The reported scores of class averages were satisfactory, with the mean scores (except for one) being similar to (or higher than) the mean of the CUNE students in the traditional format.
